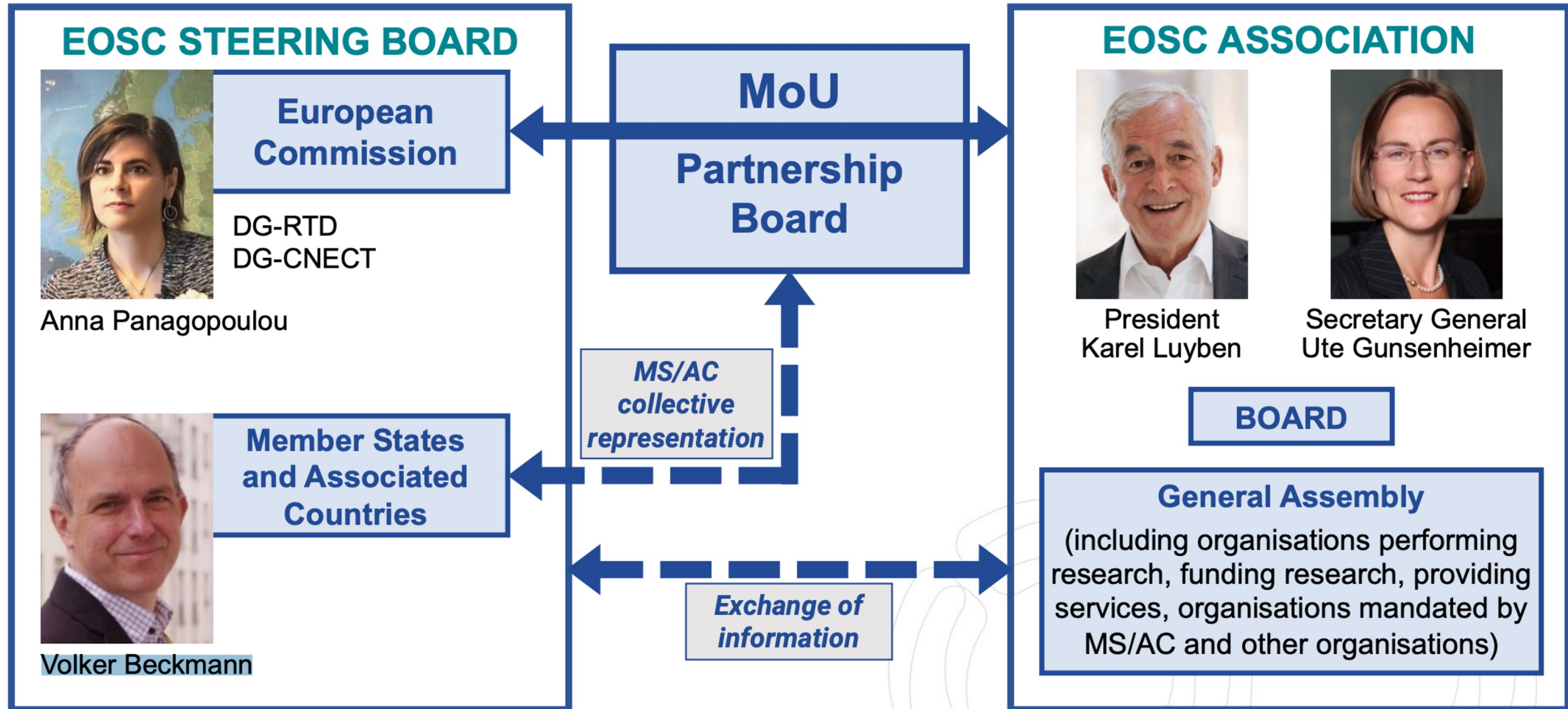

# EOSC SB TASK

---

1. Serve as Partnership interface with the countries.
  - Bringing national policies, priorities and interests to the EOSC Partnership
  - and serving as interface with the Ministries on the EOSC developments, needs, and requirements.
2. Coordinate actors/efforts/activities at national level to promote the involvement in EOSC.
3. Integrate and coordinate EOSC policies/developments in the broader environment of ERA, coordinating positions and efforts with other initiatives and actions as those established in the EPA.

# EOSC SB CURRENT ACTIVITIES

---

## EOSC POLICIES (SG on Policy): papers+recommendations

- Better coordination between RIs and EOSC.
  - RIs: FAIR Data providers and knowledge hubs on OS.
  - RIs are example of MS+AC coord. joint investment for construction & Operation (2B in investment)
  - Legal structure facilitate the federation of data, services & e-infrastructures to EOSC.
- Reduce fragmentation in data production/curation/computing/storage
- Promoting the increase on data productivity

# EOSC SB CURRENT ACTIVITIES

---

## EOSC MONITORING (SG on Monitoring):

- **Why?** to show the state of development of EOSC at MS & AC level and measure the progress. With the aim to show the added value of EOSC
- **How?** Surveys gathering information of MS+AC on policies/practices/funding at national level.
- **Who?** Accredited MS representatives upload data
- **What?** EOSC observatory = Monitoring Platform. EOSC-Future
- **Discussions:**
  - Data trustability and homogeneity of data presentation.
  - Data confidentiality and MS control on the visualisation of results
  - Sustainability of the observatory.
  - How to harmonise the observatory with other monitoring exercises/platforms running in the context of ERA: EOSC-A, ERA FORUM, Open Science.

2nd survey is under final design. Launch of the next survey before the end of 2023.

- A unique model cannot fit the needs of all the countries: FLEXIBILITY



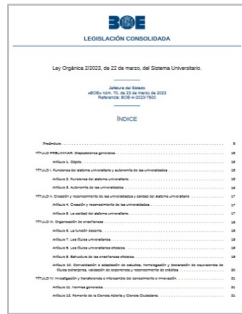

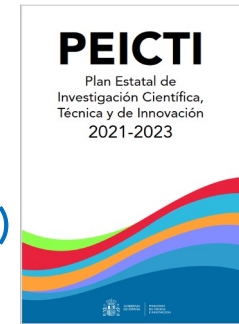
# Legal framework of Spanish R&I System



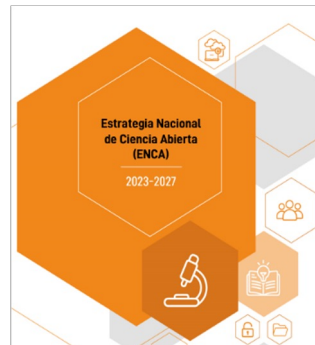
Science, Technology and Innovation Law 2022



Spanish Science, Technology and Innovation Strategy 2021-2027 (EECTI)



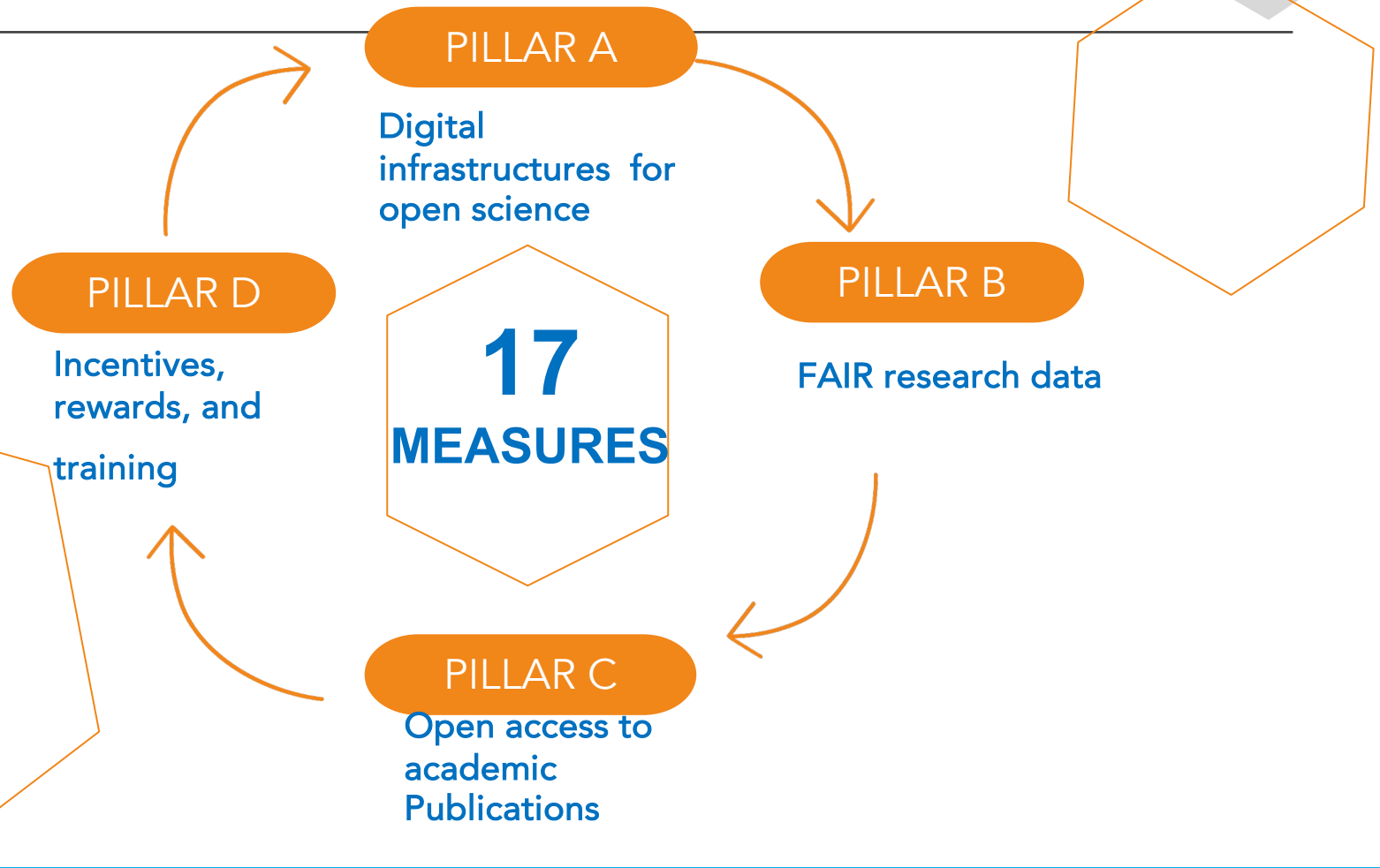
State Plan for Scientific, Technical and Innovation Research 2021-2023 (PEICTI)

# NATIONAL STRATEGY FOR OPEN SCIENCE: 4 PILLARS

Mission: to strengthen the quality, transparency and reproducibility of the scientific activity in Spain, to improve dissemination among scientific personnel and transfer to society, and to design the ways to respond to the challenges faced by the Spanish scientific community in this new global paradigm.





# DIGITAL INFRASTRUCTURES

**Identification** of digital infrastructures, both national and international, necessary for the implementation of the ENCA.

**Generation and maintenance** of new digital infrastructures for storage and preservation of research outputs necessary for the implementation of the ENCA.

**Financing** of digital infrastructures for open science.

**Interoperability** of all open science digital infrastructures to guarantee their sustainability and facilitate the integration of data and services into the European Open Science Cloud (EOSC).

**Expected outcome:** *Ensure the existence of sufficiently robust and well-articulated interoperable digital infrastructures capable of absorbing the impact of implementing a national open science policy and facilitating its integration into the international ecosystem, including, where applicable, the European Open Science Cloud (EOSC).*
